Housing/Council Tax Benefit Over Time


This report analyses housing and council tax benefit claimant data provided for the production of the Social Atlas between 2005 and 2012.

Borough level over time

The number of households claiming housing or council tax benefit has risen from 15,600 in 2005 to 24,324 in 2012.

Looking at the rate per 1,000 dwellings (to adjust for the growth in numbers because of the population growth) the trend is also upwards, although it may have peaked; the rate fell slightly between 2010 and 2012.

Estate and Settlement level over time

The pattern of housing and council tax benefit claimants is not uniform across the borough. Some estates have significantly above average proportions of claimants. Maps 1 and 2 show the rates per 1,000 dwellings for estates in 2005 and 2012. They outline that between 2005 and 2012 in the main the same estates show up as having the highest rates. Beanhill, Netherfield, Coffee Hall, Conniburrow, Tinkers Bridge, Fishermead, Fullers Slade, Hodge Lea, Stacey Bushes, Granby, and Water Eaton all show up in the highest category in both years.

Map 1: Rate of housing/council tax benefit 2005




Table 1 shows the top ten estates between 2005 and 2012. It outlines that Beanhill has had the highest rate in all eight years. Netherfield was also in the top three in all years and Coffee Hall in the top five in all years.
