#### Population

- The population of Linford South in 2011 was 9,670.
- Linford South had a population increase between 2001 and 2011 similar to Milton Keynes as a whole. The population increased by 1,390 people (16.8%) to 9,670 people between 2001 and 2011.
- Linford South had an older age profile than Milton Keynes as a whole. It had a smaller percentage of the population in the younger age groups; 17.2% were aged under 15 compared with 21.0% in Milton Keynes. It had a larger percentage in the older age groups; 13.5% were aged over 65 compared with 11.1% in Milton Keynes.
- The highest growth occurred in the 90+ year old age group. The number of people aged 90+ more than doubled from 40 people in 2001 to 90 people in 2011. By contrast the number of people aged 10-14 decreased by 110 people (-17.5%).
- 31.5% of the Linford South population were from a black and minority ethnic group. This compares to 17.1% in 2001 and 26.1% for Milton Keynes as a whole.
- The black and minority ethnic groups that increased the most between 2001 and 2011 were Black African (1.3% of the population in 2001 to 5.9% in 2011) and White Other (2.2% of the population in 2001 to 6.3% in 2011).
- 23.2% of the population in Linford South were born outside of the UK. This is significantly higher than Milton Keynes (18.5%).

#### Health

- 780 residents said their day to day activities were limited a lot because of health issues. This is 8.1% of the population compared with 6.4% for Milton Keynes.
- 900 residents in Linford South provided some unpaid care a week. This is 9.3% of the population compared with 8.8% in Milton Keynes as a whole.

#### Housing

- Linford South had a smaller percentage of households with dependent children than Milton Keynes (29.4% compared to 35.0%).
- The percentage of one person households is larger in Linford South (28.3%) than in Milton Keynes as a whole (25.9%).
- Linford South had a small average household size. It had an average of 2.4 people per household compared with 2.5 in Milton Keynes.
- A large percentage of dwellings (23.8%) in the ward were flats compared with Milton Keynes (16.2%).

- The number of flats in the ward doubled from 480 in 2001 to 980 in 2011, it increased from 14.4% of all dwellings to 23.8%.
- Overall the tenure make-up of the ward is similar to Milton Keynes as a whole. 2,200 households were living in owner occupied properties; this is 56.3% of all dwellings compared with 57.7% in Milton Keynes as a whole.
- The percentage of households living in private rented accommodation in Linford South increased from 8.5% in 2001 to 19.0% in 2011.

#### Transport

• There were 660 more cars or vans in Linford South households in 2011 compared with 2001. This is a 15.3% increase compared to the population growth of 16.8%.

#### Education

- Levels of qualifications in Linford South were slightly higher than the Milton Keynes average. 29.8% had a degree or higher compared with 28.2% in Milton Keynes. 17.1% had no qualifications compared with 18.0% in Milton Keynes.
- In addition to qualifications being higher than Milton Keynes, levels of qualifications also increased considerably between 2001 and 2011. In 2001 20.6% of residents aged 16+ had a degree or higher qualification by 2011 this had increased to 29.8%.

#### Economic

- A same percentage (68.0%) of Linford South residents aged 16-74 were in employment compared with Milton Keynes (68%).
- There was a fall from 51.6% to 47.6% between 2001 and 2011 in the percentage of the 16-74 year old population in Linford South working as full time employees.
- 85.2% of Linford South residents in employment were employed in the service sector compared with 85.3% in Milton Keynes as a whole. The wholesale and retail trade industrial sector was the largest employer of Linford South residents.
- Residents in Linford South were more likely to be classified in managerial socio-economic categories than Milton Keynes as a whole.

#### 2. Introduction

This document provides a profile of Linford South Ward from data released via the 2011 Census. The profile includes data for the ward and comparisons to Milton Keynes and to the 2001 Census figures.

#### 3. Population Size and Age Structure

## Linford South had a population increase between 2001 and 2011 similar to Milton Keynes as a whole. The population increased by 1,390 people (16.8%) to 9,670 people between 2001 and 2011.

In 2011 the population of Linford South was 9,670. Table 1 outlines that the population increased by 1,390 people; this is an increase of 16.8% compared with a 17% increase for Milton Keynes. It experienced the seventh largest population increase of all wards in Milton Keynes.

### Linford South had an older age profile than the Milton Keynes average. The average age in Linford South was 37 compared with 35 for Milton Keynes.

Table 2 shows the age structure of Linford South compared with Milton Keynes. It outlines that the ward had a higher percentage in the 65+ year old age groups and a lower percentage in the under 15 age groups. Linford South also had a high percentage of 20-29 years olds. In Linford South in 2011 17.2% of the population were aged under 15 compared with 21% in Milton Keynes. 13.5% of the population were aged 65+ compared with 11.1% in Milton Keynes.



### The highest growth rate between 2001 and 2011 in Linford South occurred in the 90+ year old age group.

Graph 2 shows the change in age structure between 2001 and 2011. It outlines that the highest growth occurred in the 90+ year old age group. The number of people aged 90+ more than doubled from 40 people in 2001 to 90 people in 2011.

Other age groups that grew significantly include the 60-64 (+110%) and 25-29 (+60.9%) age groups.

Each of the age groups 5-19 decreased in size. The 10-14 year old age group had the biggest decrease. It declined by 17.5% from 640 people to 530.

#### 4. Ethnicity

## Overall 31.5% of the population in Linford South were from a black and minority ethnic group compared with 26.1% in Milton Keynes.


Table 3 shows the number of people in each ethnic group in Linford South compared with Milton Keynes. It outlines that the ward had higher proportions in most of the black and minority ethnic groups compared with Milton Keynes. The White Other group was the largest black and minority ethnic group in the ward. 610 people classified themselves as White Other; this is 6.3% of the population compared with 5.1% in Milton Keynes. The Black African (570 people), Indian (440) and Other Asian (440) were the next largest groups.

## The population is becoming more ethnically diverse. In 2001 17.1% of the population were from a black and minority ethnic group compared with 31.5% in 2011.

Graph 3 outlines that there were a number of ethnic groups in Linford South which experienced very high population growth between 2001 and 2011. The Black African ethnic group had the highest growth in Linford South between 2001 and 2011. In 2001 it accounted for 1.3% of the population by 2011 it accounted for 5.9%, this is an increase from 105 people to 570. Other ethnic groups which increased significantly between 2001 and 2011 include White Other (2.2% to 6.3%) and Other Asian (0.6% to 4.6%).

## 23.2% of the population in Linford South were born outside of the UK. This is significantly higher than Milton Keynes as a whole (18.5%).

23.2% of the population in Linford South were born outside of the UK; this is a total of 2,245 people. Table 4 shows the country of birth for Linford South residents compared with Milton Keynes.

1.0% of the Linford South population were born in Ireland and 2.1% were born in EU member states as at March 2001. 380 people where born in 2001-2011 EU accession countries; this is 3.9% of the population significantly higher than Milton Keynes as a whole (2.5%). 1,570 people (16.3%) were born outside of the EU, significantly higher than the Milton Keynes figure of 13.0%.

The number of Linford South residents born outside of the UK increased from 1,080 people to 2,245 between 2001 and 2011.

### 690 people living in Linford South had been living in the UK for less than five years.

7.1% of the total Linford South population had lived in the UK for less than five years, significantly higher than Milton Keynes as a whole (5.4%).

#### 6. Household Language

### 7.8% of households in Linford South had no adult who had English as their main language compared with 6.4% in Milton Keynes.

86.1% of households in Linford South had all adults in the household with English as their main language and 92.2% had at least one adult with English as their main language.

310 households had no adult who had English as their main language. This is 7.8% of the population.

#### 7. Religion

## 51.5% of the Linford South population stated they were Christian, 4.5% Muslim and 5.0% Hindu. 30.9% of the population in Linford South stated they had no religion.


Table 7 shows the number of people in each religious group in Linford South compared with Milton Keynes. It outlines that the largest religious group in Milton Keynes was Christian which accounted for 51.5% of the population, this is slightly lower than Milton Keynes as a whole (52.8%).



480 people in the ward identified themselves as Hindu this is 5.0% of the population compared with 2.8% in Milton Keynes.

Graph 4 outlines the changes in religion in Linford South between 2001 and 2011. It shows that there was a decline in the percentage of the population that stated they were Christian (62.1% to 51.5%) and an increase in the percentage that stated they had no religion (23.8% to 30.9%), Hindu (2.7% to 5%) and Muslim (2.7% to 4.5%).





#### 8. Health

# 8.1% of residents in Linford South said their day to day activities were limited a lot because of health issues. This compares to 6.4% in Milton Keynes as a whole.

The 2011 Census asked two questions on the health of residents. Both questions highlight that a larger percentage of the population in Linford South felt that they had health issues when compared to Milton Keynes.

## 1. Are your day-to-day activities limited because of a health problem or disability which has lasted, or is expected to last, at least 12 months?

780 people stated their day-today activities were limited a lot due to health; this is 8.1% of population compared with 6.4% in Milton Keynes. This is the fourth highest percentage of all wards in Milton Keynes. In total 16.3% of residents in Linford South stated they were limited a lot or a little. This compares to 13.9% in Milton Keynes.

#### 2. How is your health in general?

465 respondents in Linford South felt their general health was bad or very bad. This is 4.8% of the population compared with 4.1% of the Milton Keynes population. 83.5% of residents in the ward felt they had good or very good health compared with 85.1% in Milton Keynes.

The 2011 Census questions on health were different to the 2001 Census and therefore can not be directly compared.

Health status is very strongly correlated to age. Residents in the older age groups tend to be less healthy than younger age groups. Therefore to make robust comparisons between areas health by age is needed.

#### 9. Carers

### 900 residents in Linford South provided some unpaid care a week. This is 9.3% of the population compared with 8.8% in Milton Keynes as a whole.

The 2011 Census asked respondents if they provided some unpaid care each week to others either because of a long term disability or old age. The results show that around 900 people in Linford South provided some unpaid care. This is 9.3% of the population, compared to the Milton Keynes figure of 8.8%.

Table 10 shows the number of hours of unpaid care residents undertook each week. It outlines that around 310 people undertook more than 20 hours of unpaid care each week with 180 of those undertaking more than 50 hours.



### The number of Linford South residents providing unpaid care increased by 240 people (36.6%) between 2001 and 2011.

The number of Linford South residents providing unpaid care grew from 660 in 2001 to 900 in 2011. As a percentage of the Milton Keynes population it increased from 8.0% in 2001 to 9.3% in 2011.

Graph 5 outlines that those that were providing unpaid care were doing so with greater hours. 3.2% of the population provided unpaid care for 20 or more hours a week compared with 2.4% in 2001.

#### 10. Living Arrangements

### Linford South had a lower percentage of residents living in a couple than Milton Keynes as a whole.

4,440 residents aged 16 and over in Linford South were living as a couple this is 57.0% compared to 60.4% for Milton Keynes. 2,040 (26.2%) residents were single (never married) whilst 440 people (5.7%) were widowed.

#### 11. Household Composition

### Linford South had a lower percentage of households with dependent children than Milton Keynes as a whole.

There were 3,910 households in Linford South in 2011. 460 (11.8%) of these households were one person pensioner household, this compares to 8.7% for Milton Keynes as a whole. In total 28.3% of households in the ward were one person households compared with 25.9% for Milton Keynes.

In total 1,150 (29.4%) households in Linford South had dependent children this compares to 35.0% in Milton Keynes.

260 households, or 6.6%, in Linford South were lone parent households with dependent children. This compares to 8.3% in Milton Keynes as a whole.

### The percentage of households with dependent children in Linford South decreased from 35.9% in 2001 to 29.4% in 2011.

Table 13 outlines how household composition changed between 2001 and 2011. The percentage of households with dependent children fell from 35.9% of households to 29.4%.

The percentage of lone parent households with dependent children decreased from 7.0 % in 2001 to 6.6% in 2011.

#### 12. Rooms and Bedrooms

### The ward had a smaller average household size to Milton Keynes. It had an average of 2.4 people per household compared with 2.5 in Milton Keynes.

The ward's average household size of 2.4 was the tenth lowest of all 23 wards in Milton Keynes. The average household size decreased from 2.5 to 2.4 between 2001 and 2011.

Linford South had a smaller number of rooms per household than Milton Keynes. There was an average of 5.3 rooms per household compared with 5.5 in Milton Keynes.

#### 210 households in Linford South lived in over occupied accommodation.

The 2011 Census also estimates the number of households with a high occupancy rating. An occupancy rating of -1 implies that a household had one less room/bedroom than required. Table 15 shows that Linford South had around 210 households (5.3%) which were over occupied in terms of bedrooms. This is higher than the Milton Keynes figure of 5.1%.

Over occupancy in terms of rooms increased in percentage between 2001 and 2011. In 2001 6.8% of households had an occupancy rating of -1 or less, in 2011 it had risen to 9.7%.

#### 13. Accommodation Type

### A larger percentage of dwellings were classified as flats in Linford South than Milton Keynes as a whole.

There were 4,100 dwellings in Linford South in 2011. The 2011 Census asked residents what type of dwelling they lived in. Significantly larger proportions (23.8%) of dwellings in the ward were flats compared with Milton Keynes (16.2%).


Linford South had a lower percentage of semi-detached dwellings (22.5% compared to 28.1%) compared with Milton Keynes as a whole. This is the third lowest percentage of all wards in Milton Keynes.

### Overall the number of dwellings in Linford South grew from 3,360 in 2001 to 4,100 in 2011. This is an increase of 740 dwellings or 21.9%.

Graph 6 outlines that the number of flats in the ward doubled from 480 in 2001 to 980 in 2011, it increased from 14.4% of all dwellings to 23.8%. The percentage of dwelling which were houses or bungalows decreased from 85.6% in 2001 to 75.3% in 2011.

#### 14. Tenure

### Over half (56.3%) of households in Linford South live in owner occupied properties. This compares to 57.7% in Milton Keynes as a whole.

Overall the tenure make-up of the ward is similar to Milton Keynes as a whole. 2,200 households were living in owner occupied properties; this is 56.3% of all households compared with 57.7% in Milton Keynes as a whole.

A slightly lower percentage of households lived in the council rented accommodation in Linford South than Milton Keynes. 390 households (9.9%) lived in council rented accommodation compared to 11.0% in Milton Keynes.

Linford South had a lower percentage of households in other social rented accommodation than Milton Keynes. There were 230 households in social rented housing other than from the council accounting for 5.8% of households compared with 7.1% in Milton Keynes. 740 households were in private rented accommodation (including living rent free); this is 19.0% of households compared with 18.3% in Milton Keynes.



### The percentage of households living in private rented accommodation in Linford South increased from 8.5% in 2001 to 19.0% in 2011.

Between 2001 and 2011 the number of households in Linford South living in private rented accommodation increased by 165% from 280 households to 740. It increased from 8.5% of all households in 2001 to 19.0% in 2011.

The number of households living in social rented accommodation decreased slightly in percentage from 16.8% to 15.7%.

There was a large decrease in the percentage of households living in owner occupied properties in Linford South from 66.3% in 2001 to 56.3% in 2011. The percentage of households in shared ownership increased from 8.4% to 9.1%.

#### 16. Car or Van Availability

#### 20.7% of households in Linford South had no cars or vans in the household.


In total in 2011 there were 4,980 cars or vans in households in Linford South compared with 4,320 in 2001. However 810 households in the ward had no car or van. This is 20.7% of all households, higher than Milton Keynes (18.9%).

#### 18. Qualifications and Students

## Levels of qualifications in Linford South were slightly higher than the Milton Keynes average. 17.1% had no qualifications compared with 18.0% in Milton Keynes.

Table 20 shows the highest level of qualifications for residents aged 16+. It outlines that roughly 1,350 people aged 16+ in Linford South had no qualifications. This is 17.1% of the population and is slightly lower than Milton Keynes (18.0%).

About 2,350 people aged 16+ in the ward had a degree or higher qualification. This is 29.8% of the population, slightly higher than the Milton Keynes average of 28.2%. 8.1% of the 16+ population had an 'Other qualification'. This is the third highest percentage of all wards in Milton Keynes.



### Levels of qualifications in Linford South increased significantly between 2001 and 2011.

Graph 9 outlines how levels of qualifications changed between 2001 and 2011. In 2001 20.6% of residents aged 16+ had a degree or higher, by 2011 this had increased to 29.8%. In 2001 20.7% of the population had no qualifications by 2011 this had decreased to 17.1%.

## Linford South had a slightly larger percentage of students aged 18+ than Milton Keynes.

Table 21 shows that there were 310 people aged 18 and over in full time education resident in the ward. This is 3.9% of the population, higher than the Milton Keynes average of 3.5%.

#### **19. Economic Activity**

### The same percentage (68%) of Linford South residents aged 16-74 were in employment compared with Milton Keynes (68%).

Table 22 outlines that the population aged 16-74 can be broken down into two broad categories:

### 1. Economically Active: People that were in work or looking and available for work.

5,475 people in the Linford South were economically active. This is 75.7% of the 16-74 year old population similar to the Milton Keynes figure of 75.9%. The percentage of the population working as full time employees is slightly higher in Linford South compared with Milton Keynes as a whole. 3,440 residents in the ward were full time employees; this is 47.6% of the 16-74 year old population higher than the Milton Keynes average of 46.3%.

There were 310 unemployed people in Linford South which accounted for 4.3% of the population, lower than the Milton Keynes rate of 4.8%.

### 2. Economically Inactive: People that were not in work and were not looking and available for work.

Linford South had a similar percentage of the 16-74 population who were economically inactive to Milton Keynes as a whole. 24.3% of the ward's 16-74 population were economically inactive compared with 24.1% in Milton Keynes as a whole. 3.7% of 16-74 year old population were longer-term sick or disabled compared with 3.2% in Milton Keynes.



### There was a fall in the percentage of 16-74 year old population working as full time employees in Linford South.

Graph 10 outlines that the percentage of the 16-74 population employed as full time employees decreased from 51.6% in 2001 to 47.6% in 2011. However, there was an increase in the percentage of people in part time employment and self employment which offsets this decrease to some degree. This is a trend experienced nationally.

The percentage of people who were unemployed increased from 2.8% to 3.4%. The percentage of people who were economically inactive increased slightly from 23.8% to 24.3% between 2001 and 2011. This is due to an increase in the percentage of people who were retired from 7.6% in 2001 to 10.9% in 2011.

Economic activity is strongly correlated to age. Middle aged people tend to be more economically active than younger people (who may be students) and older people (who were more likely to be retired etc). Therefore to make robust comparisons between areas economic activity by age is needed.

#### 20. Hours Worked


## Three quarters of Linford South residents in employment worked full time hours whilst a quarter worked part time.

The 2011 Census asked those in employment how many hours they worked a week. Table 23 outlines that in total 1,160 Linford South residents worked part time hours this is 24.7%, the same as the Milton Keynes average of 24.7%.

#### 21. Industry

### 85.2% of Linford South residents in employment were employed in the service sector compared with 85.3% in Milton Keynes as a whole.

4,340 Linford South residents in employment were employed in the service sector. This is 85.2% of employment compared with 85.3% in Milton Keynes as a whole. A similar percentage of residents were employed in the manufacturing sector as Milton Keynes as a whole. 440 Linford South residents were employed in the manufacturing sector; this is 8.6% of those in employment.

## The wholesale and retail trade industrial sector was the largest employer of Linford South residents.

Table 24 provides more detail on the industry of employment in Linford South and Milton Keynes. It shows that the wholesale and retail trade was the largest employer of residents in the ward. 1,030 residents were employed in this sector; this is 20.3% of people in employment compared with 20.6% in Milton Keynes. Education, health and social work and public administration, defence and compulsory social security employs 1,250 people (24.6%).

#### 22. Occupation

### 11.4% of residents in Linford South were employed in manager, director and senior official occupations and 11.3% in elementary occupations.

A slightly higher percentage of employees (11.4%) were employed in the managerial occupations in Linford South compared with Milton Keynes as a whole (10.9%). 570 residents were employed in elementary occupations. This is 11.3% of those in employment and is lower than the Milton Keynes average of 12.3%.


970 residents in Linford North were in employment in professional occupations, this is 19.1% of those in employment compared with 18.2% in Milton Keynes.

## The largest increase in employment between 2001 and 2011 in Linford South occurred in professional occupations the largest decrease occurred in managers, directors and senior officials.

Graph 12 outlines that the largest increase in employment between 2001 and 2011 in Linford South occurred in professional occupations. 12.2% of those in employment in 2001 were employed in professional occupations by 2011 this increased to 19.1%. The largest decrease occurred in managers, directors and senior officials from 17.7% to 11.4%.

#### 23. National Statistics – Socio-Economic Classification

#### Residents in Linford South were more likely to be classified in higher managerial and professional occupations and lower managerial, administrative and professional occupations socio-economic categories than Milton Keynes as a whole.

925 residents aged 16-74 in the ward were in the higher managerial and professional category. This is 12.8% of the population compared with 12.2% in Milton Keynes. Linford South also had a larger percentage of people in the lower managerial, administrative and professional occupation category.

Linford South had a lower percentage of residents in the semi-routine and routine categories than Milton Keynes as a whole.
